March in Review

In March 2021, the Policy team of EPF focused its activities on setting the scene for engagement in key dossiers and policy areas for the months to come.

On 23 March, EPF ran the webinar '[Evaluating the Cross-Border Healthcare Directive: have patients' rights improved a decade on?](#)', organised in collaboration with the European Commission DG Sante. The webinar, joined by over 50 EPF members and representative from their broader patients' communities, focused on the evaluation and consultation work on the **Cross-border healthcare Directive** (2011/24/EU). Following an introduction on EPF's work in this policy area, European Commission representatives presented the key

be available in the coming weeks and will be shared through our communication channels.

On 24 March, our Acting Executive Director Elisabeth Kasilingam, presented EPF's views on the **EU4Health programme** during a dedicated [public virtual workshop](#) organised by the European Commission. Elisabeth's presentation, which will be soon available together with the session's recording and material on the European Commission website, built on our [recent work](#) on the topic. EPF's intervention highlighted key expectations from the patient's community on the Programme's policy areas and focused on the essential role of patient organisations in shaping and delivering the Programme going forward. This should be enabled by inclusive and meaningful consultation processes and adequate resources to assist organisations in carrying out their crucial activities.

The Policy team is also working on two key webinars taking place in April and May. On 14 April, EPF will organise a joint event with **CEmPaC** (the Centre for Empowering Patients and Communities) 'Changing healthcare – partnerships for patient empowerment'. Finally, on 21 May, in collaboration with the European Commission, we will run a webinar on the European Health Data Space dedicated to our members. Information on both events will be shared soon, stay tuned!

Ensure adequate resources for patient organisations to enable their key role through the **adoption of a more inclusive operating grants approach and enhanced funding opportunities**.

Capacity Building Module on Fundraising and Engagement 2021

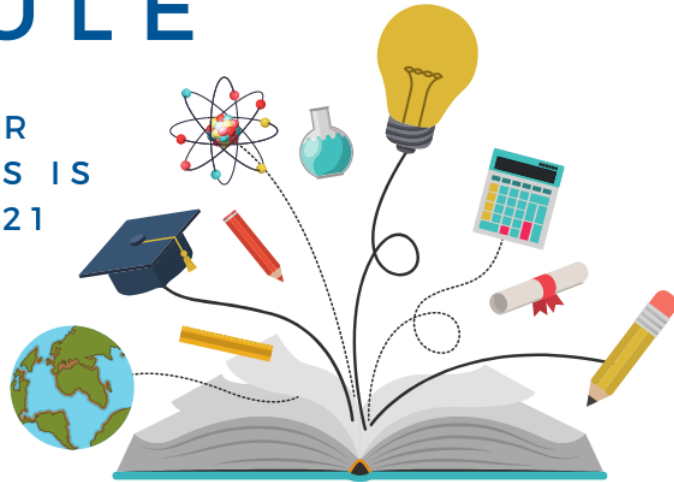
The Fundraising and Engagement topic of this year's capacity building module arises from the uncertainty and difficulties that patient organisations are put through, during the COVID-19 pandemic. Patient organisations are under great pressure to keep running their day-to-day work as well as respond to the new emerging needs from their members. The pandemic crisis has made it difficult for many to secure funding from membership fees, and attend in-person fundraising events and conferences.

In 2021, the economic crisis is starting to impact patient organisations, as funding is diverted towards other beneficiaries, leaving patient organisations to seriously rethink their fundraising strategy. In this framework, supporting the fundraising and engagement strategy is key to ensure the sustainability of patient organisations.

EU moves to fast-track vaccine approval for new coronavirus variants

The Commission announced plans to imminently introduce new provisions in EU legislation to fast-track approval of booster vaccines that could target new variants. Under the HERA incubator, which aims to solve the threat of new coronavirus variants that can bypass current vaccines, the Commission's fast track procedure will mean that companies can submit a smaller data set to the European Medicines Agency for booster vaccines — that is, shots that have been adapted from already approved vaccines. The Commission also proposed an additional €345.2 million from the EU budget to fund existing and new coronavirus initiatives this year, with part of this funding going to HERA's work on sequencing variants. €100 million would be available for urgent initiatives. However, the funds still need to be agreed by Parliament and the Council.

Joint HTA proposal to proceed to negotiations with Parliament

The long stalled proposal for EU-wide joint health technology assessment has received backing from the EU's member countries, clearing the path for negotiations with the European Parliament, an EU diplomat said today. The latest [proposal](#) was presented to member country representatives at a meeting for Coreper, where it received a mandate to proceed to trilogue.

MEPs vote to fast-track coronavirus travel pass

MEPs have agreed to fast-track voting on the European Commission's plan to create a bloc-wide travel pass that confirms coronavirus vaccination, immunity or testing status. The Commission unveiled its proposal for the so-called digital green certificate, which is supposed to help re-start robust travel across the bloc. It has pushed to roll out the certificates swiftly, with plans to have the pass operational by June.
